FIRST READING OF HOUSE BILLS

The following bills were read the first time and referred to the committees indicated.

H.F. No. 346: A bill for an act relating to courts; prohibiting certain contracting arrangements for freelance court reporting services; regulating certain services; proposing coding for new law in Minnesota Statutes, chapter 486.

Referred to the Committee on Judiciary.

H.F. No. 379: A bill for an act relating to mortgage registry and deed taxes; making technical and clarifying changes; defining terms; amending Minnesota Statutes 1998, sections 287.01; 287.03; 287.04; 287.05; 287.08; 287.10; 287.11; 287.12; 287.13, subdivision 1; 287.21, subdivision 1; 287.22; 287.23; 287.24; 287.241; 287.29, subdivision 1; 287.30; 287.31; and 287.33; proposing coding for new law in Minnesota Statutes, chapter 287; repealing Minnesota

Statutes 1998, sections 287.06; 287.07; 287.09; 287.21, subdivisions 2 and 4; 287.34; 287.35; and 287.36.

Referred to the Committee on Rules and Administration for comparison with S.F. No. 381, now on General Orders.

REPORTS OF COMMITTEES

Senator Moe, R.D. moved that the Committee Reports at the Desk be now adopted. The motion prevailed.

Senator Ranum from the Committee on Judiciary, to which was referred

S.F. No. 552: A bill for an act relating to government data practices; requiring the revisor of statutes to reorganize and recodify the data practices law; requiring responsible authorities to annually provide the revisor of statutes with lists of statutes pertaining to data practices codified outside chapter 13; amending Minnesota Statutes 1998, section 13.05, by adding a subdivision.

Reports the same back with the recommendation that the bill be amended as follows:

Page 2, delete section 2 and insert:

"Sec. 2. [REPORT OF DATA PRACTICES LAWS.]

The responsible authority of each state agency shall prepare a list that identifies all data practices laws codified outside Minnesota Statutes, chapter 13, that are not referenced in Minnesota Statutes, section 13.99. The list must be submitted to the office of the revisor of statutes no later than September 1, 1999, so that the revisor can complete the data practices law recodification required in section 1."

Amend the title as follows:

Page 1, line 4, after "authorities" insert "of state agencies"

Page 1, line 5, delete "annually"

Page 1, line 7, delete everything after "13" and insert a period

Page 1, delete line 8

And when so amended the bill do pass. Amendments adopted. Report adopted.

Senator Ranum from the Committee on Judiciary, to which was referred

S.F. No. 1094: A bill for an act relating to probate; changing provisions of the Uniform Probate Code; changing nomination provisions for conservators and guardians; amending Minnesota Statutes 1998, sections 524.2-101; 524.2-213; 524.2-702; 524.3-916; and 525.544, subdivision 1.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, line 14, delete "decedents" and insert "descendants"

Pages 1 and 2, delete section 2

Page 9, after line 32, insert:

"Sec. 5. [INSTRUCTION TO REVISOR.]

The revisor of statutes is directed to remove the words "executor" and "administrator" or similar terms each place that the words appear in chapter 48 of Minnesota Statutes and replace

those words with "personal representative" or similar terms, provided that any reference to the "administrator of veterans affairs" shall not be changed. The revisor of statutes is directed to add the word "conservator" or similar term to each section of chapter 48 of Minnesota Statutes where there appears the word "guardian," except where the word "guardian" is followed by the words "of a minor.""

Renumber the sections in sequence

Amend the title as follows:

Page 1, line 5, delete "524.2-213;"

And when so amended the bill do pass. Amendments adopted. Report adopted.

Senator Ranum from the Committee on Judiciary, to which was referred

S.F. No. 1115: A bill for an act relating to courts; revising the process for action for payment or collection of taxes; amending Minnesota Statutes 1998, section 270.68, subdivision 1.

Reports the same back with the recommendation that the bill do pass. Report adopted.

Senator Ranum from the Committee on Judiciary, to which was referred

S.F. No. 1116: A bill for an act relating to courts; eliminating filing of duplicate documents; updating the law governing court administrators; amending Minnesota Statutes 1998, sections 279.13; 485.018, subdivision 2; repealing Minnesota Statutes 1998, sections 357.07; and 485.018, subdivisions 1 and 4.

Page 1, line 24, after the comma, insert "or any other law to the contrary,"

And when so amended the bill do pass. Amendments adopted. Report adopted.

Senator Lessard from the Committee on Environment and Natural Resources, to which was referred

S.F. No. 1090: A bill for an act relating to counties; authorizing Koochiching county to exercise the power of eminent domain for acquisition of certain trust fund land.

Reports the same back with the recommendation that the bill be amended as follows:

Page 1, line 11, after the comma, insert "reserving to the state all minerals and mineral rights,"

And when so amended the bill do pass. Amendments adopted. Report adopted.

Senator Lessard from the Committee on Environment and Natural Resources, to which was referred

S.F. No. 1091: A bill for an act relating to state lands; authorizing conveyance of certain tax-forfeited land in Koochiching county.

Reports the same back with the recommendation that the bill do pass. Report adopted.

Senator Novak from the Committee on Jobs, Energy and Community Development, to which was referred

S.F. No. 607: A bill for an act relating to tax expenditures; requiring preparation of certain information for proposed tax expenditures; regulating business subsidies; requesting a study by the legislative auditor; appropriating money; amending Minnesota Statutes 1998, section 270.067, subdivision 4; proposing coding for new law in Minnesota Statutes, chapters 3; and 116J; repealing Minnesota Statutes 1998, section 116J.991.

Reports the same back with the recommendation that the bill be amended as follows:

Delete everything after the enacting clause and insert:

"Section 1. [3.9831] [TAX EXPENDITURE STATEMENTS.]

Subdivision 1. [PREPARATION REQUIRED.] (a) Before a committee hearing on a bill that proposes to create a new or expand an existing tax expenditure, the author must provide the committee with the following information in writing:

- (1) a clear and concise statement of the public purpose for each proposed tax expenditure and expansion of an existing tax expenditure; and
- (2) the author's expectations concerning: (i) any other economic or social costs of the proposal; (ii) economic or social benefits of the proposal; and (iii) the individuals or groups of individuals who will benefit and who will pay as a result of the proposal by income class or other appropriate demographic characteristics. If the full cost of the proposed tax expenditure is not offset by explicitly increasing taxes on other taxpayers, the expectation of who will pay must name particular budget expenditures that will be reduced by that amount.
- (b) The commissioner of revenue must provide the committee with an estimate of the effect on state and local government revenues. An estimate of the cost of administration by state government must be prepared by the appropriate head of the affected state agency or agencies, as coordinated by the commissioner of finance.
- <u>Subd. 2.</u> [DEFINITIONS.] (a) For purposes of this section, the terms in this subdivision have the meanings given.
 - (b) "Tax expenditure" means a provision of tax or other law that:
- (1) consists of a special exemption, deduction, exclusion, credit, rate, or similar provision that reduces the tax obligation of an individual, business organization, property, or transaction;
 - (2) serves or is intended to serve an economic or social goal other than raising revenue; and
- (3) is not a fundamental element of the tax that is primarily designed to achieve one or more of the following tax policy goals:

- (i) horizontal or vertical equity;
- (ii) efficiency or minimizing the impact of the tax on private decisions;
- (iii) ease of administration of the tax;
- (iv) ease of compliance by taxpayers; and
- (v) simplicity or understandability of the tax.
- (c) "Tax" means any tax of statewide application or any tax authorized to be imposed by local governments generally. It does not include a local tax imposed under a special law or a local tax imposed under a general law that no longer applies to local governments generally.

Sec. 2. [116J.993] [DEFINITIONS.]

<u>Subdivision 1.</u> [SCOPE.] For the purposes of sections 116J.993 to 116J.996, the terms defined in this section have the meanings given them.

- Subd. 2. [BENEFIT DATE.] "Benefit date" means the date that the recipient receives the business subsidy. If the business subsidy involves the purchase, lease, or donation of physical equipment, then the benefit date begins when the recipient puts the equipment into service. If the business subsidy is for improvements to property, then the benefit date refers to the earliest date of either:
 - (1) when the improvements are finished for the entire project; or
- (2) when a business occupies the property. If a business occupies the property and the subsidy grantor expects that other businesses will also occupy the same property, the grantor may assign a separate benefit date for each business when it first occupies the property.
- Subd. 3. [BUSINESS SUBSIDY.] "Business subsidy" or "subsidy" means a state or local government agency grant, contribution of personal property, real property, infrastructure, the principal amount of a loan plus the interest on any loan at rates below those commercially available to the recipient, any reduction or deferral of any tax or any fee, any guarantee of any payment under any loan, lease, or other obligation, or any preferential use of government facilities given to a business.

The following forms of financial assistance are not a business subsidy:

- (1) assistance that is generally available to all businesses or to a general class of similar businesses, such as a line of business, size, location, or similar general criteria;
- (2) public improvements to buildings or lands owned by the state or local government that serve a public purpose and do not principally benefit a single business or defined group of businesses at the time the improvements are made;
- (3) redevelopment of blighted buildings or property polluted by contaminants as defined in section 116J.552, subdivision 3, when the property is sold at 80 percent or more of appraised market value based on comparable property;
- (4) assistance provided for the sole purpose of renovating or bringing up to code old or decaying building stock and when the assistance is matched by the business using private sources;
- (5) assistance provided to organizations whose primary mission is to provide job readiness and training services if the sole purpose of the assistance is to provide those services;
 - (6) assistance for housing;
 - (7) assistance for pollution control or abatement;
 - (8) assistance for energy conservation;

- (9) assistance awarded through direct and specific legislation;
- (10) tax reductions resulting from conformity with federal tax law;
- (11) workers' compensation and unemployment compensation;
- (12) benefits derived from regulation;
- (13) indirect benefits derived from assistance to educational institutions; and
- (14) a business subsidy of less than \$25,000.
- Subd. 4. [GRANTOR.] "Grantor" means any state or local government agency with the authority to grant a business subsidy.
- Subd. 5. [LOCAL GOVERNMENT AGENCY.] "Local government agency" includes, without limitation, a statutory or home rule charter city, housing and redevelopment authority, nonprofit agency established by a local government agency, town, county, port authority, and economic development authority.
- Subd. 6. [POVERTY LEVEL WAGE.] "Poverty level wage" means compensation on an hourly basis equivalent to 110 percent of the federal poverty threshold for a family of four. Compensation includes wages and the employer's costs for health and dental insurance.
- Subd. 7. [RECIPIENT.] "Recipient" means any for-profit or nonprofit business entity that receives a business subsidy. Only nonprofit entities with a ratio of highest to lowest paid employee exceeding ten to one are included in this definition.
- <u>Subd. 8.</u> [STATE GOVERNMENT AGENCY.] "State government agency" means any state agency that has the authority to award business subsidies.
 - Sec. 3. [116J.994] [REGULATING LOCAL AND STATE BUSINESS SUBSIDIES.]

Subdivision 1. [PUBLIC PURPOSE.] A business subsidy must meet a public purpose other than increasing the tax base. Job retention may only be used as a public purpose in cases where job loss is imminent and demonstrable.

- Subd. 2. [DEVELOPING A SET OF CRITERIA.] A business subsidy may not be granted until the grantor has adopted criteria for awarding business subsidies that comply with this section. The commissioner of trade and economic development may assist local government agencies in developing criteria.
- <u>Subd. 3.</u> [SUBSIDY AGREEMENT.] (a) A recipient must enter into a subsidy agreement with the grantor of the subsidy that includes:
 - (1) a description of the subsidy, including the amount and type of subsidy;
 - (2) a statement of the public purposes for the subsidy;
 - (3) goals for the subsidy;
 - (4) a description of the financial obligation of the recipient if the goals are not met;
 - (5) a statement of why the subsidy is needed; and
- (6) a commitment to continue operations at the site where the subsidy is used for at least ten years after the benefit date.
- (b) An agreement must structure grants as forgivable loans, provided that if a business subsidy cannot be structured as a forgivable loan, the agreement must state the fair market value of the subsidy to the recipient, including the value of conveying property at less than a fair market price, or other in-kind benefits to the recipient.

- (c) If a business subsidy benefits more than one recipient, the grantor must assign a proportion of the business subsidy to each recipient that signs a subsidy agreement. The proportion assessed to each recipient must reflect a reasonable estimate of the recipient's share of the total benefits of the project.
- (d) The state or local government agency and the recipient must both sign the subsidy agreement and, if the grantor is a local government agency, the agreement must be approved by the local elected governing body.
- <u>Subd. 4.</u> [WAGE AND JOB GOALS.] <u>The subsidy agreement, in addition to any other goals, must include:</u>
- (1) goals for the number of jobs created, which may include separate goals for the number of part-time or full-time jobs, or, in cases where job loss is imminent and demonstrable, goals for the number of jobs retained; and
- (2) wage goals for the jobs created or retained. Large employers that receive business subsidies must pay at least poverty level wages for at least 90 percent of all new jobs created as a result of the business subsidy. For purposes of this subdivision, "large employer" has the meaning given it by section 177.24, subdivision 1.

In addition to other specific goal time frames, the wage and job goals must contain specific goals to be attained by two years of the benefit date.

- Subd. 5. [PUBLIC NOTICE AND HEARING.] (a) Before granting a business subsidy that exceeds \$500,000 for a state government grantor and \$100,000 for a local government grantor, the grantor must provide public notice and a hearing on the subsidy. Hearings for local government business subsidies must be held by the corresponding locally elected body. A public hearing and notice pursuant to this subdivision is not required if a hearing and notice on the subsidy is otherwise required by law.
- (b) Public notice of a proposed subsidy must be published in a local newspaper of general circulation and must identify the location at which information about the business subsidy, including a copy of the subsidy agreement, is available. Published notice should be sufficiently conspicuous in size and placement to distinguish the notice from the surrounding text. The grantor must make the information available in printed paper copies and, if possible, on the Internet. The government agency must provide at least a ten-day notice for the public hearing.
 - (c) The public notice must include the date, time, and place of the hearing.
- Subd. 6. [FAILURE TO MEET GOALS.] The subsidy agreement must specify the recipient's obligation if the recipient does not fulfill the agreement. At a minimum, the agreement must require a recipient failing to meet subsidy agreement goals to pay back the assistance plus interest provided that repayment may be prorated to reflect partial fulfillment of goals. The interest rate must be set at the implicit price deflator defined under section 275.70, subdivision 2.

A recipient that fails to meet the terms of a subsidy agreement may not receive a business subsidy from any grantor for a period of five years from the date of failure or until a recipient satisfies its repayment obligation under this subdivision, whichever occurs first.

- <u>Subd. 7.</u> [REPORTS BY RECIPIENTS TO GRANTORS.] (a) A business subsidy grantor must monitor the progress by the recipient in achieving agreement goals.
- (b) A recipient must provide information regarding goals and results for two years after the benefit date of the subsidy or until the goals are met or until the subsidy has been paid back, whichever is longer. This information must include, without limitation:
 - (1) the type, public purpose, and amount of subsidies;
 - (2) the hours worked and hourly wage of each job created within separate bands of wages;

- (3) a description of benefits provided for each job created; and
- (4) a statement of goals identified in the subsidy agreement and an update on achievement of those goals.
 - (c) A recipient shall file with the grantor:
 - (1) a progress report no later than February 10 of each year for the previous year; and
 - (2) a progress report within 30 days after the deadline of meeting agreement goals.
- (d) If the recipient does not submit its report, the local government agency must mail the recipient a warning within one week of the required filing date. If, after 14 days of the postmarked day of the warning, the recipient fails to provide a report, then a penalty of \$100 per day applies until the report is filed.
- Subd. 8. [GOVERNMENT REPORTS.] (a) Each subsidy grantor must report the wage goals, job goals, and any other goals identified in the subsidy agreement and the results for each subsidy in achieving those goals to the department of trade and economic development.
 - (b) At a minimum, the items in each report must include:
 - (1) the name of the recipient and grantor;
 - (2) the amount of subsidies by type and public purpose;
 - (3) the number of part-time and full-time jobs created by separate occupational categories;
 - (4) the number of full-time and part-time jobs created within separate bands of wages;
 - (5) the benefits paid, separate from wages paid, and listed by separate bands of wages;
 - (6) the date when the goals will be reached;
 - (7) whether the goals have been reached;
- (8) whether or not the financial obligation for noncompliance with the business subsidy is being enforced;
 - (9) the name of the person filling out the form; and
 - (10) a contact person with a telephone number and the date the form was completed.
- (c) The commissioner of trade and economic development must coordinate the production of reports so that useful comparisons across time periods and across grantors can be made. The commissioner may add other information to the report as the commissioner deems necessary to evaluate business subsidies.
- (d) State and local government agencies, regardless of whether they awarded any business subsidies, must file the report required by this subdivision by March 1 of each year with the commissioner. If the commissioner has not received the report by that date, the commissioner shall issue a warning to the government agency. If the commissioner has not received a report by June 1 of the same year, then the government agency may not grant any business subsidy until it files the report.
- (e) The commissioner of trade and economic development must provide information and training on reporting requirements to state and local government agencies.
- Subd. 9. [COMPILATION AND SUMMARY REPORT.] The department of trade and economic development must publish a compilation and summary of the results of the reports for the previous calendar year by July 1 of each year. The reports of the government agencies to the department and the compilation and summary report of the department must be made available to the public.

Among the information in the summary and compilation report, the commissioner must include:

- (1) total amount of subsidies awarded in each development region of the state;
- (2) distribution of business subsidy amounts by size of the business subsidy;
- (3) distribution of business subsidy amounts by time category, such as monthly or quarterly;
- (4) distribution of subsidies by type and by public purpose;
- (5) percent of all business subsidies that reached their goals;
- (6) percent of business subsidies that did not reach their goals by two years from the benefit date;
- (7) total dollar amount of business subsidies that did not meet their goals after two years from the benefit date;
 - (8) percent of subsidies that did not meet their goals and that did not receive repayment;
 - (9) number of part-time and full-time jobs within separate bands of wages; and
 - (10) benefits paid within separate bands of wages.
- Subd. 10. [AUTHORITY TO AUDIT REPORTS.] The commissioner may audit individual recipients and government agencies to verify that the reports have been filled out properly.

Sec. 4. [116J.995] [ECONOMIC GRANTS.]

An appropriation rider in an appropriation to the department of trade and economic development that specifies that the appropriation be granted to a particular business or class of businesses must contain a statement of the expected benefits associated with the grant. At a minimum, the statement must include goals for the number of jobs created, wages paid, and the tax revenue increases due to the grant.

Sec. 5. [116J.996] [PENALTY FOR BIDDING BETWEEN LOCAL GOVERNMENT AGENCIES.]

Subdivision 1. [DEFINITIONS.] (a) The definitions in this subdivision apply to this section.

- (b) "Expected payroll" means the average payroll of the business paid in the three years before the business relocates. If the business was not in operation at the old site for more than three years, then the expected payroll shall equal the annual average payroll over the time period that the business operated at the site.
- (c) "Municipality" means a statutory or home rule charter city, town, or, in the case of unincorporated territory, a county.
- (d) "Relocates" means that a local government agency has offered a business subsidy, and the subsidy is the primary reason a business has moved from one municipality to another.
- Subd. 2. [PENALTY.] Any local government agency that relocates a business must pay the municipality from which the business relocated. For purposes of this section, the payment obligation equals ten percent of expected payroll for a period of five years. If the business does not disclose its payroll, then the municipality from which the business relocated may estimate the loss in payroll with a survey.
- Subd. 3. [REMEDY.] If municipalities or local government agencies are unable to agree on the existence of, or amount of, an obligation under this section, they must submit the matter to district court.
 - Sec. 6. Minnesota Statutes 1998, section 270.067, subdivision 4, is amended to read:

Subd. 4. [CONTENTS.] The report shall detail for each tax expenditure item the amount of tax revenue foregone, a citation of the statutory or other legal authority for the expenditure, and the year in which it was enacted or the tax year in which it became effective. The report may contain additional information which the commissioner considers relevant to the legislature's consideration and review of individual tax expenditure items. This may must include, but is not limited to, statements of the intended public purpose of the tax expenditure, analysis of whether the expenditure is achieving that objective, and the effect of the expenditure device on the distribution of the tax burden and administration of the tax system.

Sec. 7. [STUDY OF TAX EXPENDITURES.]

The legislative auditor is requested to conduct a study of selected tax expenditures evaluating each program for its public purpose and effectiveness.

Sec. 8. [TAX EXPENDITURE ANALYTICAL MODEL.]

The department of revenue shall study the creation of a model that could provide an analytical dynamic tax analysis of tax expenditures. The department shall report to the tax committees of the legislature by January 15, 2000, on the results of the study and the progress in creating a model.

Sec. 9. [APPROPRIATION.]

\$..... is appropriated from the general fund for the biennium ending June 30, 2001, to the commissioner of trade and economic development to carry out the commissioner's duties under Minnesota Statutes, sections 116J.993 to 116J.995.

Sec. 10. [APPROPRIATION.]

\$...... is appropriated from the general fund for the biennium ending June 30, 2001, to the commissioner of revenue for the purposes of section 8.

Sec. 11. [REPEALER.]

Minnesota Statutes 1998, section 116J.991, is repealed.

Sec. 12. [EFFECTIVE DATE.]
